What if I change banks, but want to continue automatic monthly payments?

Advise MPHOA of the last draw date for the current bank. Complete an automatic payment request for the new bank. Submit a new voided check or savings account deposit slip. Allow 30 days for processing.

THE MT. PARK AUTOMATIC MONTHLY PAYMENT PLAN

What is the Automatic Monthly Payment Plan?

The Automatic Monthly Payment Plan is a free service available from the Mt. Park Home Owners Association (MPHOA) to its Members. The service allows MPHOA to automatically deduct your assessments and related charges monthly directly from your checking or savings account as an ACH debit.

What are the benefits?

The Automatic Monthly Payment Plan is the most convenient way to make your monthly MPHOA payments. It is a service that saves time and it means you can avoid:

- writing checks
- postage
- mail delays
- late charges.

How do I enroll in the plan?

- Complete the attached authorization form.
- Make a copy of the authorization form for your records.
- Write the word "VOID" on a blank check or savings account deposit slip. If you don't have savings account deposit slips, please confirm ABA and Account number information with your bank.
- Send your authorization form and voided check or savings account deposit slip to the address listed on the authorization form.

Automatic monthly payments are only accepted from United States banking institutions.

When will the automatic withdrawal start?

MPHOA will notify you when your request for automatic monthly payments has been approved. Continue to make regular payments until you are advised of the activation date.

When will my bank account be debited and for what amount?

MPHOA will debit your account on the 5th of each month for the monthly balance due. If it is not a business day, the account will be debited on the next business day.

Account information is available 24 hours a day, 7 days a week through our members only website at www.mtparkmember.com.
